**LOCAL LAW #1-2002**

**AMENDMENT OF THE DAY ON WHICH THE  
BOARD OF ASSESSMENT REVIEW SHALL HEAR  
COMPLAINTS RELATING TO ASSESSMENTS**

Be it enacted by the Town Board of the Town of York as follows:

**Section 1:**

Pursuant to Section 512 1(a) of the Real Property Tax Law the Town Board of the Town of York as governing body of the assessing unit which employs and Assessor who is at the same time employed by another assessing unit hereby establishes the Wednesday after the fourth Tuesday of May as the day the Board of Assessment Review shall meet to hear complaints in relation to assessments.

**Section 2:**

Any other local law, ordinance or resolution inconsistent herewith is hereby repealed.

**Section 3:**

The local law shall take effect immediately upon filing with the New York State Secretary of State as provided in Section 27 of the Municipal Home Rule Law.




