TOWN OF YORK LOCAL LAW NO. 1 OF THE YEAR 2007

A Local Law **INCREASING MAXIMUM ALLOWABLE VETERANS EXEMPTION UNDER SECTION 458-a OF THE REAL PROPERTY TAX LAW**

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF YORK AS
FOLLOWS:

SECTION 1. Section 458-a (2)(d)(ii) of the Real Property Tax Law authorizes a Town to increase the maximum allowable exemption granted to veterans for real property tax purposes.

SECTION 2. The Town of York, pursuant to the authority granted by Section 458-a (2)(d)(ii) of the Real Property Tax Law, increases the maximum allowable exemption granted under paragraphs (a) (b) and (c) of subdivision (2) of Section 458-a of the Real Property Tax Law from \$ 15,000 .00 (15% wartime veteran), \$ 10,000.00 (additional 10% combat veteran) and \$ 50,000.00 (50% for disabled veteran) to **Twenty-One Thousand Dollars (\$ 21,000.00), Fourteen Thousand Dollars (\$ 14,000.00) and Seventy Thousand (70,000.00)**, respectively. This increase shall be effective with the 2007 assessment roll.

SECTION 3. This Local Law shall be effective upon the filing with the Secretary of State of the State of New York.
