Dear Mr. Peter:

The Livingston County Planning Board, at its regular meeting on January 11, 2024, reviewed the zoning referrals from the Town of York of the above mentioned pursuant to Sections 239-1 and m of the General Municipal Law of the State of New York. The Planning Board voted to recommend "Approval" of the proposed actions with the following advisory comments:

1. Browns Creek and a 100-year floodplain are located in the northern part of the parcel.

Any development on this parcel should take these natural resources into consideration.

2. If not done already, the Town should complete the SEQR process before final action is taken.
3. If not done already, the Applicant should ensure that all proposed lighting meets the Town of York Outdoor Lighting Regulations, according to Article V, Section 518 of the Town of York Zoning Ordinance.
4. The Town should carefully consider the benefits of the requested area variances to the applicant against any potential negative impact on the neighborhood, based on the five factor “balancing test” as set forth in the state statute for area variances.

There was a quorum present at this meeting. There was a majority vote on this matter.

Mr. Geiger stated that the ZBA hearing was regarding the area variance for the 80 ft. tall leg and asked for questions. He asked Mr. Cole for comments.

Mr. Cole said the leg was to move the processed product into overhead bin.

Mr. McIlroy said that the Planning Board will not take action tonight but at our next regular meeting regarding the special use permit and the site plan.

Mr. Richenberg asked if the holding capacity would change.

Mr. Cole said they can hold everything they process now – 3 commodities. He can't say there won't be any increase in the future, but now not going to take any more than presently have (9000 bushels) and they will be focusing on soybeans.

They will be processing it in-house now instead of shipping it out to be processed. Bins will hold finished product.

Mr. Wall said soybeans come in by truck and asked how it will leave.

Mr. Cole said they will leave the same way except the oil will go into tankers. The process is done in the rear building, the front building holds the meal.

Mr. Richenberg asked about liquid storage runoff. Mr. Cole replied there will be tanks in the process building, 9000 gallons and it was non-hazardous.

Mr. Wall asked if the meal was non-hazardous from an electrical fire standpoint and Mr. Cole said everything was.

Mrs. Nagel asked if it was flammable and Mr. Cole said nothing was flammable (explosive). Mr. Cole said there was no permitting for oil or soybeans.

Mr. Richenberg asked what the special use permit was for and Mr. McIlroy answered that a special use permit is required for a food processing plant and even though it might not be for human consumption, the Code does not distinguish who the food is intended to be consumed by.

Mr. Cole asked if there was a special use permit issued to the previous owner with regard to the edible beans. Mr. McIlroy stated that a prior special use permit was likely not issued because it was prior to our zoning in 2009. Mr. Geiger said the property and use was likely pre-existing, non-conforming.

Mr. Geiger asked if there would be any extra lighting and Mr. Cole answered yes. Mr. Geiger asked if there would be lighting on the legs and Mr. Cole said not now, just a work light if needed.

Mr. McIlroy asked if there were any questions on the site plan.

Mr. Geiger asked for a motion to close the ZBA public hearing.

Resolution:

Mr. Hulburt motioned to close the ZBA public hearing at 6:50 pm, Mr. Geiger seconded, carried.

Mr. McIlroy stated that the PB public hearing would remain open until their meeting on 24th at 7:30 pm.

Mr. Campbell suggested that the planning board stay until after ZBA did the SEQR.

Mr. Hulburt moved to approve the December 17 minutes with the update of Mark Connolly's length of time on the board, Mr. Geiger seconded, carried.

Mr. Campbell, using the long form of SEQR went through it and the board answered.
